# Incorporation

DOMINION OF CANADA, PROVINCE OF BRITISH COLUMBIA, TO WIT IN THE MATTER OF THE BENEVOLENT SOCIETIES' ACT —AND—
THE CORPORATION OF THE LADIES' CLUB OF WHONNOCK

WE, Martha M. WEST, wife of George West, and Hannah G.M. KIRBY, Spinster, all of Whonnock, Province of British Columbia, do solemnly declare that:

- 1. A number of ladies including ourselves intend to unite into a corporation to be called "The Ladies Club of Whonnock".
- 2. The purposes of the corporation shall be as follows:-
  - (a) For any benevolent or provident or moral or charitable purpose.
  - (b) For the improvement and development of the moral, social and physical condition of young men and young women.
  - (c) For the promotion of literature, science or the fine arts and the promotion and diffusion of knowledge.
  - (d) For promoting the cause of temperance and moral reform.
- 3. The first trustees of the corporation shall be Annie Watson, wife of Edward Watson, Alice M. Spilsbury wife of Ashton W. Spilsbury, and Hanna[h] G.M. Kirby, Spinster, and their successors shall be appointed annually by ballot at the regular annual meeting.

AND we make this solemn declaration conscientiously believing it to be true and knowing it is of the same force and effect as if made under oath and by virtue of the Canada Evidence Act.

The purposes of the club were kept very general and their main objective, the building of a public hall, was not specifically mentioned. Note that the possessive apostrophe after "Ladies" was only used in the header.

# Introduction

The Ladies Club of Whonnock was formed and incorporated in 1911 and ceased to function in 1945. For half a century the hall the ladies built in 1912 was the heart of the community providing space for entertainment, such as dances, meetings, lectures, theatre, concerts, card competitions, fairs, shows, and "moving pictures," as well as sports such as badminton and later tennis. The Ladies Club also organized picnics and teas. Most of the activities organized by the Ladies Club itself were fund raisers to meet the debts incurred for the building of the Hall.

Without the complete minutes of meetings little is known about the life of an organization. Of course some traces of a society's activities can be found in newspapers, in a few letters, or in the frail and quickly disappearing memories of an older generation, but minute books, incomplete as the information they contain may be, are a continuing record of the progress of an organization through time.

We owe the survival of the minute books of the Ladies Club to Olive Leaf and her daughter Margaret Mattson. The Maple Ridge Museum and Archives now holds the minute books as well as a cash book and some other records of interest.

Unfortunately minute books of other Whonnock and Ruskin organizations such as our local veteran and ratepayers associations, the Thornhill hall and the last decade of the Whonnock Women's Institute, did not find their way to an archives and seem lost forever. If we want to keep our history alive an archives is the only right place to keep community records for more than a lifetime.

This transcription of the minutes of the Ladies Club 1911–1919 will allow everyone to read the text at a place and time of their choice and without the need to decipher the handwriting. I have kept close to the original text, correcting occasional spelling mistakes. There are varying spellings in surnames. As a rule I have used the name as written, unless I was certain of the correct spelling.

This issue of *Whonnock Notes* covers the first part of the Ladies Club minutes, ending with 1919, when interest in membership had faded and "...the Club being short of members was unable to do business...." To boost membership the decision was made to accept male members. That all changed when at a meeting of the people of Whonnock in December 1919 it was decided that the Hall would be "acquired and turned into a Memorial Hall." The next issue of *Whonnock Notes* will contain transcripts of the minutes of the Ladies Club, starting in 1920, as well as the minutes of the mostly male committees that took over the management of the Hall.

#### JUNE 28th 1911

A meeting was held in the Whonnock School room Wed. June 28th at 4 pm for the purpose of forming a Ladies Club.<sup>1</sup>

The second meeting of the Club was held on July 5<sup>th</sup>. The minutes of the last meeting were read and accepted.

Moved Mrs. Benson, seconded Miss Kirby that the bill for use of school house be paid. Carrried.

Moved Mrs. Spilsbury, seconded Mrs. Scott that Mesdames Moore & West interview the men of Stave Falls in regard to subscription.<sup>2</sup>

#### Carried.

Moved Mrs. Spilsbury, seconded Mrs. West that subscription lists be made out & headed by fifty dollars from the Ladies Club. Carried. [Signed A.M. Spilsbury, President; R.S. Black, Secretary]

# AUGUST 2nd [1911]

The third meeting of the Club was held on August 2<sup>nd</sup>. The minutes of the last meeting were read & accepted. Moved. Miss Kirby, seconded Mrs. Moore, that the Hall be built through subscription & that trustees be appointed to look after Hall. Carried.

## OCTOBER 4th [1911]

The fourth meeting of the Club was held on October 4<sup>th</sup>. The minutes of the last meeting were read & accepted.

A communication from Mrs. Spilsbury rendering her resignation was read & accepted.<sup>3</sup>

Moved by Mrs. Billups, seconded Mrs. West, that Miss Kirby be elected president. Carried.

Moved Mrs. West, seconded Mrs. Rolley, that the Club meet at different homes. Carried.

Letter received from Mr. Aikman asking Ladies Club to arrange for a social to introduce the new teacher. <sup>4</sup>

Moved by Mrs. Watson, seconded Mrs. Gill that a social meeting be held October 12<sup>th</sup> & that a special meeting be held on Saturday October 7<sup>th</sup> at the home of Mrs. Black. The meeting adjourned. [Signed H. G. Kirby, President; R.S. Black, Secretary]

# OCTOBER 7<sup>th</sup> [1911]

The fifth meeting of the Club was held on October 7<sup>th</sup> at the home of Mrs. Black. The minutes of the last meeting were read at the special meeting and accepted.<sup>5</sup>

I The school built in 1909 at the corner of what are now called 272nd Street and 100th Avenue was still a one-room affair in 1911.

The "men at Stave Falls" worked on the construction of the power station. The members of the Ladies Club worked tirelessly to gather funds for the building of the hall. The Fraser Valley Record of 10 August 1911 reports on perhaps the first event organized: "The ladies of Whonnock intend holding a big

Moved by Mrs. Rolley, seconded Mrs. Hamilton, that Mrs. West's expenses be paid to go to town to interview lawyer regarding incorporation of Club. Carried.

The next meeting was arranged to be held at the home of Mrs. Rolley. The meeting adjourned.

#### NOVEMBER 1st [1911]

The sixth meeting of the Club was held at the home of Mrs. Rolley. The minutes of the last meeting were read & accepted.

A communication from Mrs. G. Gilchrist rendering her resignation was read & accepted.

Moved Mrs. Benson, seconded Mrs. Fletcher that Mrs. Spilsbury be elected vice president. Carried.

A communication from Mrs. Black rendering her resignation as secretary was read & accepted.

Moved by Mrs. Rolley, seconded Mrs. West, that Mrs. Billups be elected secretary. Carried.

The new secretary then reported having received the resignation of Mrs. Scott, Pullen, Hamilton, Mrs. G. & A. Gilchrist; also having written several gentlemen asking them to kindly forward their subscription at their earliest convenience; also having received \$86 from the treasurer which has been placed to the credit of the Ladies Club in the bank; also that \$20 solicitors disbursements for incorporating the Club had been paid. The meeting was adjourned.

#### NOVEMBER 7<sup>th</sup> [1911]

The seventh meeting of the Club was held at the home of Mrs. Brodie. The minutes of the last meeting were read & accepted.

Moved Mrs. Black, seconded Mrs. Gill that a site for the new Hall be purchased from Mrs. West. Carried.

Moved Mrs. Black, seconded Mrs. Gill that a committee consisting of the trustees be appointed to arrange for the purchase of land &

erecting of Hall.

Mrs. Spilsbury reported having received the papers of the registration of the Club.

The Club now being legally incorporated it was moved Mrs. Rolley, seconded Mrs. Spilsbury, that the old officers be retained. Carried. Moved Mrs. Black, seconded Mrs. Fletcher, that an entertainment be held at Mrs. Watson's on Saturday night December 16<sup>th</sup>, entrance 50 cents, for the purpose of raising the \$50 promised by Ladies Club towards erection of Hall. Carried. Adjourned.

# JANUARY 3rd [1912]

The eighth meeting of the Club was held at the home of Mrs. Billups. The minutes of the last meeting were read & accepted.

Moved Mrs. Black, seconded Mrs. Watson, that the secretary write to Mrs. Moore & Miss Hodgson asking for a subscription to help to pay off the \$50. Carried.

Moved Mrs. Gill, seconded Mrs. Rolley, that Mr. Whiting's account be paid. Carried. The meeting adjourned.

# FEBRUARY 7<sup>th</sup> [1912]

The ninth meeting of the Club was held at the home of Miss Kirby, the minutes of last meeting were read & accepted.

Moved Mrs. Watson, seconded Mrs. Black, that the president, vice president, and secretary form a committee to put the Club books into order. Carried.

Moved Mrs. Boulanger, seconded Mrs. West, that Mrs. Hedley become a member of the Club. Carried.

The vice president gave notice that at the next meeting bylaws would be introduced for regulations of the Club.

Moved by Mrs. Black, seconded Mrs. Fletcher that the secretary write to subscribers who had not paid their subscription towards the Hall. Carried.

Moved Mrs. Gill, seconded Mrs. Spilsbury, that the secretary write a letter of thanks to Gilchrist Bros. for the offer of site for Hall, hauling lumber at \$100 as this letter had been forgotten. Carried. Moved by Mrs. Watson, seconded Mrs. Brodie, that Mrs. West see

the lawyer about the settlement of his bill. Carried.

Moved Mrs. Black, seconded Mrs. Fletcher, that secretary write a letter of thanks for surveying the site of Hall to Hill & Burnett, New Westminster & pay the bill of \$5 for the plans of same. Carried. Moved Mrs. Watson, seconded Mrs. Parkes, that secretary will write a letter of thanks to Rogers, Black & McAlpine for subscription & pay \$3.10 for their bill. Carried.

Moved Mrs. West, seconded Mrs. Black that the Club adjourn for tea.

The land offered by Messrs. Gilchrist was doubtless land in Ruskin and that may have caused some controversy. Most of the ladies preferred a hall in Whonnock and they decided to turn down the Gilchrist's offer. That could have caused the loss of interest in the Ladies Club and the resignation of both Mmes. George and Alex Gilchrist. In 1916 Ruskin would have its own hall on land deeded by Alex and George Gilchrist who took a leading role in the establishment of a building on the property.

Reported by Mrs. Spilsbury on behalf of the committee that the site for the Hall has been purchased from Mrs. West, being a 0.6728 acre [sic] portion of a 5.70 acre portion of Lot 455, Group 1, New Westminster District for \$300 & the deed for same as been placed in the Land Register Office that the application for the certificate of title has been accepted at the office.

Mrs. Spilsbury also presented a plan of the Hall & a bill of lumber for the same drawn up by Mr. Miller; also reported that Mr. Miller has laid out the ground for the foundation according to the plan, and had also kindly offered to give any advice necessary during the construction.

Standing vote of thanks be accorded Mrs. West for her donation of the extra amount of land given. Carried.<sup>7</sup>

The meeting adjourned until February 22<sup>nd</sup> and every week until further notice. Carried.

# FEBRUARY 22<sup>nd</sup> [1912]

The tenth meeting of the Club was held at the home of Mrs. West. The minutes of last meeting were read & accepted.

Moved Mrs. Watson, seconded Mrs. Black, that Mrs. West approach the different hardware stores & ask for estimates for same when in town. Carried.

Moved Mrs. Hedley, seconded Mrs. West, that another exit be put in the plan in case of fire in the Hall. Carried.

Moved Mrs. Boulanger, seconded Mrs. Gill, that president, vice president, & Mrs. Watson be appointed committee to see about the bylaws. Carried.

Reported by the committee that Mr. Olaus Lee was chosen to erect the Hall under the supervision of Mr. Miller.

Moved Mrs. West, seconded Mrs. Rolley, that the monthly dues be 25 cents. Carried unanimously.

Moved Mrs. Watson, seconded Mrs. Rolley, that the Club adjourn for tea.

Moved Mrs. Black, seconded Mrs. Gill, that the committee enquires at the bank also mill re the financing of the Hall lumber. Carried. Moved Mrs. West, seconded Mrs. Gill, that badges be ordered. Carried.

Moved Mrs. Spilsbury, seconded Mrs. Hedley, that the next meeting be held next Friday at Mrs. West at 3 pm. The meeting adjourned. [Signed H. G. Kirby, President; A.E. Billups, Secretary]

#### MARCH 1st [1912]

The eleventh meeting of the Club was held at the home of Mrs. West. The minutes of the last meeting were read & accepted. Moved Mrs. West, seconded Mrs. Black, that Mr. W. Kirk's estimate for hardware be accepted.

It is not not clear what extra land was donated by Mrs. West.

The secretary reported receiving a letter from Hill & Burnett stating at request that their charge for survey of Hall site would have been \$15.70 which sum has been placed to their credit on the subscription list.

Also reported the lawyer (Mr. Kruger) deducted \$5 from his account which has been placed to his credit on the subscription list.

Moved Mrs. Watson, seconded Mrs. Rolley, that the Club adjourn for tea. Carried.

Moved by Mrs. West, seconded Mrs. Gill, that the plans for the Hall be passed. Carried unanimously.

Moved Mrs. Gill, seconded Mrs. Black, that Mrs. Billups resignation as secretary be accepted. Carried.

Moved Mrs. Billups, seconded Mrs. Gill, that Mrs, Hedley be appointed secretary. Carried.

Moved Mrs. Watson, seconded Mrs. West, that the secretary write to Mr. Hayward, Stave Falls, & ask about piano. Carried.

Moved Mrs. Black, seconded Mrs. Rolley, that the Club adjourn until next Wednesday at Mrs. West. Carried.

The bylaws passed their first reading. Moved Mrs. West. [Signed H. G. Kirby, President; A.E. Billups, Secretary]

# MARCH 6<sup>th</sup> [1912]

The meeting of the Ladies Club was held on Wednesday, March 6<sup>th</sup>, at 3 o'clock at Mrs. West's. There were present eleven members. The minutes of the preceding meeting were read and accepted.

The minutes of the Club dating from the inaugural meeting of June  $28^{\rm th}$  were read and verified by Mrs, Spilsbury.

The secretary was instructed the write to Mrs. Moore, Cedar Cottage, and to Miss Hodgson, Hatzic in order to ascertain whether these ladies intended to continue their membership in the Club. The question of a canvas floor cloth came under discussion, and after various expressions of opinion, it was agreed to postpone a final decision on the matter.

The vice president reported having purchased a cash and a minute book, total cost two dollar seventy cents (\$2.70) and six receipt books, twenty-five cents (25 cents). Moved by Mrs. Black, seconded by Mrs. Gill and carried, that the outlay be refunded.

The question of the Club badge now came under discussion. The design for the Club badge was originated by Mrs. Spilsbury and drawn by Mrs. Boulanger. It represents a gold shield bearing a trillium erect, the three petals of the lily in white enamel, the three sepals in green. The design was placed for execution in hands of Mr. Birks jeweller of Vancouver. Mrs. Spilsbury reported an interview with the foreman of this firm on the cost of making up the badges. He agreed to supply them at one dollar and ten cents (\$1.10) each, provided a dozen were taken; the price to be less if possible. After general discussion it was decided that eighteen badges be purchased, and Mrs. Spilsbury was requested to order an additional six. Moved by Mrs. Spilsbury, seconded by Mrs. Rolley and carried, that

the ribbons for mounts to the badges be white for members and gold for officers and that Mrs. Fletcher be asked to send for samples of satin ribbon.

The question of remuneration for Mr. Olaus Lee was brought up for consideration and it was decided that Mrs. Spilsbury, as member of the building committee, should approach him personally on the matter.

Mrs. Spilsbury then reported:

Ist That she had ordered the lumber necessary for the building of the Hall from the Brunette Mills, and had been promised a discount of 15% on a cash deal and a donation of seventy-five dollars (\$75).

2<sup>nd</sup> That she had an interview with Mr. Bremner, manager of the Bank of Montreal in New Westminster as to raising the necessary money to cover the cost of lumber, and that Mr. Bremner had promised to do his best for the Club in this matter.

Mrs. Spilsbury then handed in the following donations: Mr. Bremner \$10; Mr. G.L. Howe \$5; Mr. E.H. Heaps \$25; Mr. G. Brine \$2.50; Mr. A.C. Mercer \$25; Mr. J.A. Agar \$5; Mr. L.A. Lewis \$75; Mr. F.J. Hart \$50; Mr. Lokyer \$5. Total two hundred and two dollars and fifty cents (\$202.50).

Some discussion arose as to the amount owing for furnishings and Mrs. West was requested to look into the question of bricks and to interview Mr. Rolston on the matter of wiring the Hall.

The following resolution was moved by Mrs. Gill, seconded by Mrs. Black and carried, that, whereas a deficit of three dollars (\$3) still remains on the donation of fifty dollars (\$50) promised by the Club to the Hall, the eleven members now present be asked for an individual contribution of 20 cents, and that those four absent members residents at present time in Whonnock, be acquainted with the resolution.

The secretary was instructed to write letters of thanks to Mr. Heaps of Ruskin and Mr. Mercer of Vancouver.

The bylaws passed their second reading, each clause being carefully considered; it was agreed that further discussion thereon should be postponed to the following meeting.

The meeting was adjourned until 3 o'clock on Wednesday, 13<sup>th</sup> inst. at Mrs. West's.

## MARCH 13<sup>th</sup> [1912]

The meeting of the Ladies Club was held at 3 o'clock on Wednesday, March 13<sup>th</sup> at Mrs. West's. There were present eleven members. The minutes of the preceding meeting were read and accepted.

<sup>9</sup> Power from the Stave River had begun to flow in December 1911. The *Fraser Valley Record* of March 7th reports that Maple Ridge Council gave instructions that "...the Clerk write the Western Canada Power Co, asking them to use every effort to supply power to Whonnock as the residents most urgently require it." The Hall was one of the first public buildings in Maple Ridge wired for electric light and heating.

Correspondence: The secretary reported writing to Messrs. Hayward, Tisdale, Ross, Tom Warren, Holms, and H.J. Kirk and receiving a receipt of deposits of \$120 from Bank of Montreal, letter and receipt from H.J. Kirk, and letter and three copies of bylaws from Mr. Kruger.

Two copies of the bylaws were signed as required by the president and secretary and the secretary was instructed to return them for registry, stamped with the corporate seal.<sup>10</sup>

Secretary also instructed to write to Mr. F.J. Hart for promised donation of \$50.

Reports of committees:

Mrs. Spilsbury reported:

I<sup>st</sup> Having received a statement of account from the Brunette Lumber Mills amounting in all to \$1015.82cts less discount.

2<sup>nd</sup> That steps in Hall were required to be four instead of three and that certain small amount of lumber would be required.

It was suggested that during the summer, and pending the choice of heating apparatus for the Hall, the cooking stove be placed out of doors.

Miss Kirby reported the offer of a cooking stove from Mrs. Johnson and the secretary was instructed to write and accept offer with thanks.

An offer of stove piping was made by Mrs. Gill, present, also a promise of bunting.

The question of stage curtains was brought up for discussion and it was suggested that Mrs. Spilsbury write for prices of [...ggets], also of bunting and of flags.

A request was made by Mr. Walroud to the effect that he be allowed to employ Olaus Lee for his own use for two days. Moved Mrs. Spilsbury, seconded Mrs. West, that the meeting adjourn until Wednesday April 24<sup>th</sup> at 3 o'clock at Mrs. West's. Carried. [Signed H.G.M. Kirby, President; E.A. Hedley, Secretary]

APRIL 24th [1912]

The meeting of the Ladies Club was held at 3 o'clock on April 24<sup>th</sup> at Mrs. West's. Present eight members.

Minutes: The minutes of the preceding meeting were read. Moved Mrs. Spilsbury, seconded Mrs. West that they be accepted. Carried. Finance: The treasurer's report was read and showed; cash \$1051.30cts; disbursements \$810; balance \$241.30cts. Mrs. Spilsbury presented detailed account of the Brunette Saw Mill Co. Ltd. amounting to \$840 with receipt for \$810; and reported that our promissory note for \$700 had been accepted by the Bank of Montreal, New Westminster; interest on the rate of 7%.

A donation of \$2 was received from Mr. John Macdonald. Mrs. West reported that the rate of insurance given by Rogers & Black was \$20 for a term of three years.

Mrs. West presented a letter received from Mr. Salsbury with details as to the cost of heaters and lighting.

The secretary was instructed to write to Mr. J. Montgomery, W.C.P. Co. Carter-Cotton building, Vancouver for cost estimate of heaters and rate of power for light and heaters. Also to enquire approximate date to expect power in Whonnock.

Mrs. Spilsbury showed pattern of beaver [?] board with which it was suggested to line the Hall. It would cost \$15 to \$20 more than wood—about 1000 ft V joint and 4000 ft beaver board would be required.

Ist She reported that Lee of New Westminster would supply chairs flat for 55cts. Tables for 63cts.

2<sup>nd</sup> That eighteen badges had been received at \$1.20cts and that a die had been made. The secretary was instructed to Mr. Macgarland, reeve of Haney, giving him by request a statement comprising value of Hall (viz. \$3000), amounts donated, and expenses and sum required for completion.

The president stated that a piano sent by Ross of New Westminster for the Hall was lying at the station. Price of piano \$350+\$25 off as donation. Terms \$18 cash, \$6 each month for six month, \$8 for next six month and \$10 after first year. Interest 6%. It was decided to take the piano to the Hall and be tried and that it be returned if not satisfactory. Members were requested to make enquiries about second-hand pianos and collect all information possible.

The question of curtains for the windows came up and Mrs. West was requested to look into the matter of using glass paper.

Twelve badges were taken by members.

The annual meeting was fixed for May 2<sup>nd</sup>. Secretary instructed to send notice thereof to absent members—also to write to Coquitlam Printing Works for estimate of printing 200 tickets abd 12 posters. **Annual Meeting** 

The first annual meeting of the Ladies Club was held on May 2<sup>nd</sup>, Thursday, at 3 o'clock at Mrs. West's. Present eleven members. Presidents address: The president, in reviewing the work of the Club during the past year, laid particular emphasis on the voluntary help received from the men of Whonnock toward the building of the Hall. She was of opinion that special thanks were due to Mr. Spilsbury for the amount of thought and careful work given by him. Also to Mrs. Spilsbury and Mrs. West for their continuous and unflagging efforts on behalf of the Club. She considered that without the three named workers the Hall would certainly not have reached the stage it was at today.

The chief business of the meeting was the election of officers and of an executive committee for the ensuing year. The particular reason for the executive being that the business of the Club should be transacted by the committee instead of, as at present, at the general meetings.

The monthly meetings were to be continued but were to partake of a social nature. Each member of the executive would have equal power and all business would be carried by vote.

The president concluded her address by saying that she had always considered herself as holding a temporary office and did not want to stand for re-election.

There was never a "grand opening" of the new Hall.

Barbara Christine Garner's father Robert Robertson died on 1 May 1912. She became a widow in 1910, left to fend for herself and her children. Her brother-in-law Sam Roy Garner went to war under the assumed name Roy Cromarty and gave her financial support until he was killed at the front.



The meeting of the Ladies Club was held at the Hall for the first time on Monday 27th May 1912. This snapshot, probably by Alice Spilsbury, may well be the first one taken of the Hall, just after its completion.

A chimney was added on this side in the fall of 1912.

It was proposed that the token presented by the Club to Mrs. Garner should take the form of a brooch, and it was suggested that brooches should be looked at in Vancouver. Mrs. West was requested to order a can of coal oil and a box of cones for the dance on the 17<sup>th</sup>. Moved Mrs. Gill, seconded Mrs. Fletcher, that three gentlemen be asked to act as wardens for the Club during the coming year, the duty of warden being to maintain order at the various entertainments given at the Hall. 

# By-laws of The Ladies Club of Whonnock

WHEREAS the officers and members of the Ladies Club of Whonnock deem it expedient that by-laws for regulating the society be made.

NOW THEREFORE be it enacted and it is hereby enacted as follows:

- I. The head office of the society shall be at the Town of Whonnock, Province of British Columbia at such place therein as the society from time to time may determine.
- 2. The seal, the impression of which on the margin hereof shall be the seal of the society.
- 3. The annual general meeting of the members of the society shall be held at such time in the month of May and at such place as the society may determine.
- 4. A special general meeting may be called by the Secretary at any time at the request in writing of three members of the Committee or by motion at a general meeting of twelve members of the club. The special matter to be considered being stated. Seven days notice to the members shall be given of such meeting and by whom required, and the special matter to be considered thereat, no other question shall be considered at the meeting.
- 5. The President or in her absence the Vice president shall preside at general meetings, or in the absence of both, the meeting shall elect a chairman. No business shall be transacted at any general meeting at which less than eight members are present.
- 6. The management ad administration of the club shall be vested in a committee consisting of three Trustees, Vice-president and two members of the club. The committee shall meet when and where they deem advisable. Twenty-four hours notice at least must be given each member of the committee. Four members shall constitute a quorum. In case of equality of votes, chairman shall have casting vote in addition to her own as committee man.
- 7. The committee shall be elected in the following manner, written nominations shall be handed to the Secretary at the annual general meeting, and the list of the names in ballot form shall be handed to each member present at the meeting, such ballot papers shall be marked by the members and shall then be collected and votes counted by two scrutineers appointed by chairman of the meeting, the two members having the highest number of votes shall form the balance of the committee for the ensuing year. All officers and trustees shall be nominated and elected in the same manner as the committee.
- 8. The committee or the general meeting may as any time appoint a sub-committee consisting of as many members as they may decide and may define the powers iof such sub-committee. Such sub-committee may be discharged at any time by the body that appointed them.

- 9. At the decision of a majority of two thirds of a general meeting, salaries or remunerations may be allowed officers.
- 10. The committee shall have power to enter into contracts, etc., all such being signed by President, Secretary and bear the corporate seal
- II. The treasurer of the club shall be The Bank of Montreal, New Westminster B.C.
- 12. A committee or other officers may be removed at any special general meeting and another appointed in his stead.
- 13. At all committee or general meetings all questions shall be decided by majority of members present and entitled to vote, save and except as provided in clauses 9, 14, 17, 18, and 19.
- 14. Any candidates for membership must be nominated, seconded and balloted on, at a general meeting and a majority of three quarter votes cast required for election. Candidates shall not be less than 18 years of age.
- 15. The entrance fee shall be two dollars and fifty cents (\$2.50) or such sum as may be determined by a general meeting from time to time. The annual subscription shall the three dollars (\$3.00) or such sum as may be determined by a general meeting from time to time. Subscriptions shall become due on the first day of each quarter of the year, namely January 1st, April 1st, July 1st, and October 1st, payable in advance. All members who have not paid within thirty days after the notice is written, the secretary shall report the fact to the committee who shall erase her name from the list of members and thereupon she shall cease to be a member of the club but she may be readmitted by the committee upon her giving such reasons as they consider satisfactory for her non-payment.
- 16. The secretary shall produce her books for inspection by the committee, or auditors, whenever required.
- 17. In case the conduct of a member either in or out of the club premises shall in the opinion of the committee be unworthy of a member of the club the committee may by a two-third vote of all the members of the committee call upon such member to resign and should she refuse, may suspend or expel her from the club, such suspension or expulsion may be revoked by a two-third vote of a special meeting of the club.
- 18. Any amendment to this constitution may be made at a special general meeting by two-thirds vote of the members present.
  19. The dissolution or winding up of the club shall only be deemed resolved upon when a resolution to that effect shall have been adopted by a two-third vote of the members present at a special meeting called to consider the proposal and confirmed by a like majority at a special meeting called for a like purpose not less than two weeks nor more than five weeks after its first adoption.
